Regarding continuation / extension of provisional affiliation of existing courses with earlier sanctioned intake and provisional affiliation for introduction of new PG programmes, i.e., M. Tech. in Civil Engg. (24 seats), M. Tech. in Computer Science & Engg. (24 seats) and M. Tech. in Electronics & Communication Engg. (24 seats) for the session 2013-14 in respect of Gateway Institute of Engg. & Tech., Gateway Campus, Sector-11, Sonepat.

It is intimated that the inspection committee, constituted by this University, inspected your institute on 16.05.2013 to verify the compliance of previous conditions of affiliation and availability of requisite faculty, staff and infrastructural facilities of existing courses, for / from the session 2013-14 & has submitted the report.

The Vice-Chancellor, after considering the report, has been pleased to grant extension / continuation in provisional affiliation for existing courses, i.e., B. Tech. in CSE (60 seats), ECE (60 seats), ME (60 seats), CE (60 seats), BHM (60 seats), M. Tech. in Mechanical Engg. (24 seats) and provisional affiliation for introduction of new PG programmes, i.e., M. Tech. in Civil Engg. (24 seats), M. Tech. in Computer Science & Engg. (24 seats) and M. Tech. in Electronics & Communication Engg. (24 seats) for from the session 2013-14.

Large efforts are required, backed up by sustained institutional pursuance and monitoring to overcome the perennially occurring deficiencies, in particular regarding faculty & equipments, such that there are demonstrated results within the time frame set forth.

The above provisional affiliations are subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance, and the instructions issued by this University from time to time. Further, it is made clear to the institute that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.

The extension / continuation in provisional affiliation for the said existing courses and new courses is further subject to the condition that your institute will make full compliance of the observations / deficiencies pointed out in the report by the inspection committee within one month or before the commencement of academic session 2013-14 (whichever is earlier). The compliance of the same alongwith supporting documents (such as bills of materials / items procured, selection committee proceedings, joining reports, photographs of facilities created, etc.), be submitted to this university at the earliest.
