Subject: Regarding continuation / extension of provisional affiliation of existing courses with earlier sanctioned intake for the session 2014-15.


It is intimated that the inspection committee, constituted by this University, visited your institute on 24.06.2014 to check the availability of requisite infrastructural facilities, labs, faculty and other support systems, etc. to consider the matter of continuation / extension in provisional affiliation of existing UG/PG courses, i.e., B. Tech. in CSE, ECE, ME and Civil Engg. with intake of 60 students each and M. Tech. in ME, CE, CSE and ECE disciplines with intake of 24 students each and BHM (60 seats) for the session 2014-15 and has submitted the report.

The Vice-Chancellor, after considering the report, has been pleased to grant provisional affiliation for the session 2014-15 for the existing courses with earlier sanctioned intake, i.e., B. Tech. in CSE (60 seats), ECE (60 seats), ME (60 seats), CE (60 seats), BHM (60 seats) and M. Tech. in Mechanical Engg. (24 seats), CE (24 seats), CSE (24 seats) and ECE (24 seats) for the session 2014-15 subject to the fulfillment of the deficiencies pointed out by the inspection committee. The photocopy of the inspection report dated 24.06.14 is enclosed herewith for necessary compliance (alongwith all supporting documents / proofs such as bills of materials / items procured, photographs / maps of facilities created etc.). The compliance report be submitted within one month.

The above provisional affiliation for the existing UG/PG courses with earlier sanctioned intake is further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time.

Further, it is made clear that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.
