The Vice-Chancellor, after considering the report, has been pleased to grant continuation / extension in provisional affiliation for **starting of new Courses i.e. BBA (60 seats) and BCA (60 seats)** for/from the session 2018-19 **subject to the submission of affiliation fee of Rs. 5.00 lakh plus 18% GST (i.e. Rs. 2.50 lac with 18% GST per course as per fee structure) within 10 days and compliance of observations/recommendations as pointed out by the Inspection Committee in the inspection report dated 25.04.2018. A photocopy of the inspection report dated 25.04.2018 is enclosed herewith for necessary compliance (alongwith all supporting documents / proofs). The compliance report may be submitted at the earliest.**

The above provisional affiliation for **new Courses i.e. BBA (60 seats) and BCA (60 seats)** for/from the session 2018-19 is subject to the condition that the institute shall make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time.
